01. Huge Lie - Enlightened Householding.

On Patton West's website she had a posting entitled 'Enlightened Householding' this was recently changed to '[Modern Enlightenment](#).' A pack of lies as can be seen when ones gets a glimpse of the reality of her sordid private home life. The following are excerpts from testimony given in court. And this about Marijuana, Cocaine and Alcohol..

18	Q.	Um, when was Sasha born?
19	A.	August 8 th , 2006 -- or August 24 th , I'm sorry,
20		8/24/06 -- that's -- I got the 8.
21	Q.	Um, and when were you married?
22	A.	Uh, 2006 of -- July 2 nd .
23	Q.	Okay. And, um, did your husband consume any
24		drugs during that marriage ceremony?
25	A.	Yes.
1	Q.	What drugs were being used there?
2	A.	Marijuana and cocaine and alcohol.
3	Q.	And you actually observed that?
4	A.	Yes.

And this about Pornography Etc. (Only brought up because Patton West deems to lecture the public about 'Enlightened Householding / Modern Enlightenment.)

1 A. I think that the computer pornogra --

2 pornography deal is just absolutely disgusting and I

3 don't think that -- when he drinks he thinks with the

4 same mind, he'll just go do it and in the fact that it

17 to a friend of mine, so I can't have friends at my

18 house due to the fact of him being so sexual.

20 A. With them or with himself or with myself.

The above is the tip of the iceberg when it comes to depravity mentioned in court. Only someone mentally ill or incredibly evil with their record of depravity would consider 'lecturing' the public on 'Enlightened Householding!'



02. Huge Lie - The Extortion of Dr. Pat Cole's Entire Net Worth.

Patton West's charity was [struck off](#) the Montana charity register for fraud in January 2004. Additionally Patton West was the subject of legal action which resulted in her having to sell her 'visible' assets at a [Sheriff's Sale](#) to force her to pay past victims of crime \$2,000,000 in court fines and interest. This meant her giving up her Victor MT compound with the result that she moved 100 miles north to Lakeside MT which she told the members of her cult was Shamballa. In an [email](#) sent to the entire cult entitled 'Financial Withhold' Patton West announced that she could opnly take 12 disciples to 'shamballa' and only those willing to commit 66% of their net worth to Patton West lifestyle costs. We believe that Dr. Cole MD followed Patton West to Montana in 1995 when Patton West was chased out of New Mexico by one gun wielding victim who understood the police could not help him. So Cole decided to be one of the 12 disciples that agreed to commit two thirds of their net worth to the fake guru. Unfortunately for Cole Patton West got tired of waiting for Cole to hand over her wealth so to help matters proceed she, Patton West, launched a campaign of overt and covert violence against Cole which culminated in a vicious assault that the police were called to. The [Whitefish Pilot](#) newspaper covered the assault in detail. [A temporary restraining order against West, who calls herself Surya Ma, was issued by Judge David Ortley last October after Dr. Patricia Cole, of Whitefish, requested protection. "She has told me that she has the 'spiritual' power and authority to 'talce me out,' to be composted," Cole wrote in the temporary restraining order statement. Cole claims West threw a lamp at her and hit her with a briefcase, cell phone and her hand. "She took off her shoe and hit me on th top of my head, causing my scalp to bleed onto my face, neck and clothes," Cole's statement reads."She threatened to killme with a gun to my head, 'blowing my brains out,' and advised me to conunit suicide by slitting my wrists, after I'd talcen out an insurance policy onmyself."](#)

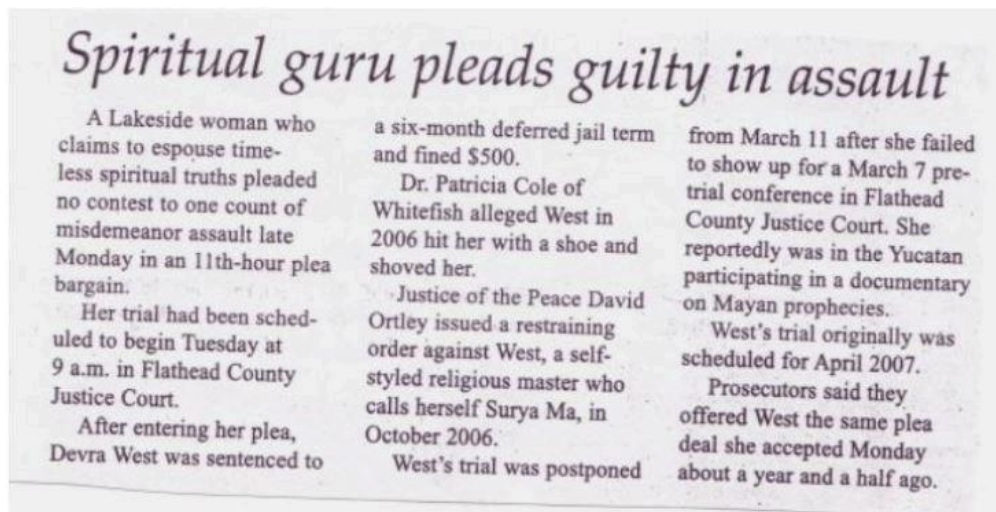

The assault on Cole caused such a lot of trauma amongst employees and cult members that Patton West was forced to do damage limitation. So to be clear in the above missive Patton West admits the beating of Cole and admits the beating was severe. Immediately after the whistleblower posted a copy of her admission of guilt on his website Patton West got stooge Reynolds to claim copyright over the document in an attempt to have it removed from public access. The denials began after the [Whitefish Pilot](#) & [Bigfork Eagle](#) newspapers reported the assault in 2007 and her guilty verdict in 2008.



The first public denial occurred in court on July 12 2007. While acting as a lying witness for her son she was asked if she had assaulted Dr. Pat Cole MD. The Master Liar of course answered No, no way, no how even though her admission of guilt was posted on-line for all to see. This counts as perjury but as Montana is still the 'wild west' perjury is not prosecuted. Which is one reason why Patton West operates only in western states. Court Rules to Dismiss Bogus Assault Case:

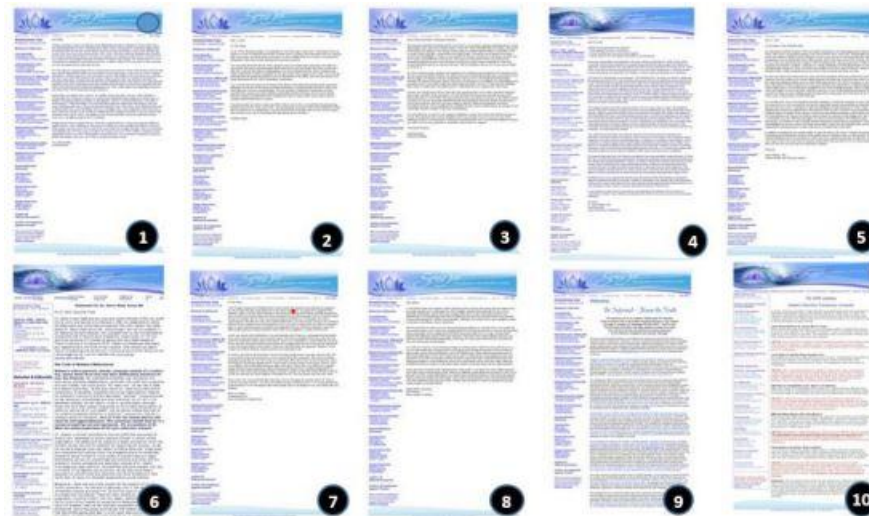
All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

Like the pathological liar Patton West is she states that the 'Court Rules to Dismiss' the Bogus Assault Case.' She goes on to say that all allegations have been expunged from the court records. The reality is that the case was never dismissed. However

because the 'liars for hire' members of her cult all posted statements of denila Patton West got away with 'Misdemeanor Assault.' Knowing that misdemeanors are removed from the court records after a short period Patton West declares that the case was dismissed and expunged from the records. 03. John Watson Wins his Fraud Lawsuit Against Patton West. In 2008 fraud victim turned whistleblower John Watson won his fraud lawsuit against Patton West. Business partner of Victor Guru Wins lawsuit

The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court. Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages.

Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment. The case was heard in Ravalli County because West's home and business operations - the Divine Unity Foundation and the Sacred Archives Institute - were in Victor, where Watson also lived. Langton entered a default judgment against West, who calls herself Surya Ma, on July 16 after she failed to show up for a number of court hearings and to respond to court deadlines. West did not attend Thursday's hearing. Her business manager, Geoff Reynolds, attended but declined to comment and said West would not comment....

Shortly after the above newspaper article was published Patton West did just as she did with Dr. Pat Cole's verdict against her (see above). Basically denying the court's verdict and saying that the verdict stemmed from a 'technical error.' Here is her statement..

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

The lies are so blatant. It is though Patton West knows that she is not going to be charged with perjury or contempt of court in Montana. Like all psychopaths Patton West, who tried to murder Watson in August 2007, projects her own crimes on to her victims. In Watson's case Patton West accuse him of threats against her and her family. In reality since December 2006 patton West has been using her [occult \(hidden\) weapon](#) to attempt to intimidate Watson into dropping his lawsuit against Patton West. Patton West goes on to lie about their business relationship stating that, and I quote, "No business contract between West and Watson ever existed. If this was the case (which it was not) then why did Patton West send [this email](#) to her lawyer Tabarachi asking him to untie their business relationship? If there was no business arrangements between West & Watson then why would they both sign this [promissory note](#) guaranteeing payment to the the Cactus Design Agency? And if Watson was not in a business arrangement with Patton West why did they both have business cards made for Millennia Mind?



The final nail in the coffin if another is needed comes from Patton West's 5 year personal secretary Barbara Costantino who gave a [statement](#) which made it clear that everytime Patton West screws someone over she invents a fake reason as to why they left. Here is a short excerpt from her statement...

I also confirm that Mr. Watson was regarded by Ms. West in a very favorable light right up until he left and that Mr. Watson was not asked to leave. Mr. Watson walked out on Ms. West because, in his own words, he felt that she 'lacked integrity.'

I can confirm also that, after Mr. Watson's departure, Ms. West began to lie about the circumstances of his departure and the nature of his employment.

These facts can be corroborated by other employees of the Circle of Divine Unity Foundation, including Ms. Tanya Hurley, Ms. Kellie Jackson, and Ms. Anne Stout, the office manager.

An ordinary person, let alone the police or law courts, cannot understand just how big a liar Patton West really is. They all give people the benefit of the doubt until they are caught out in their lies. There are so many lies from Patton West and they are so huge as to boggle the mind of ordinary folk.

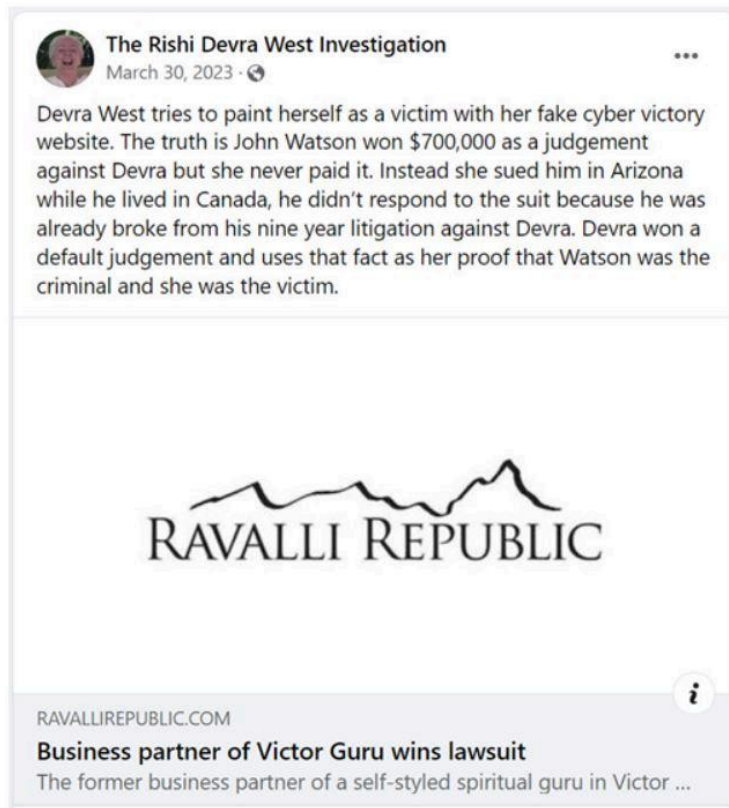
04. Huge Lie - Legal Victory Against John Watson - A Big Lie.



In brief fraud victim turned whistleblower [successfully sues](#) Patton West for fraud and was [awarded](#) \$740,000 in costs and damages. While appearing in court in 2010 for Patton West's appeal she and Geoffrey Reynolds (a senior member of her cult / criminal racketeering gang) serve Watson with two defamation lawsuits. The truth is an absolute defense against defamation but only if you can afford to defend against others lies in court. Watson had moved abroad in 2005 and after defending his fraud lawsuit at great expense over a 5 year period he could not afford to travel to and from the USA to defend against Patton West and Reynolds' lies. By the way Reynolds was a total stranger to Watson who had only joined Patton West's employ in September 2006. And yet Patton West & Reynolds were convinced Watson could not afford to travel to the USA to oppose their lies so Reynolds perjured himself. He did so by copying Patton West's submission to court in effect stating that he too was defamed between 2002 & 2006 by Watson. 05. Huge Lie About the Assault on student Beatrice McGuire.

While attending a seminar in Montreal, Canada in early 2002 Patton West viciously assaulted student Beatrice McGuire in front of a large audience for calling out some of Patton West's many lies. Apparently Patton West grabbed Beatrice by her ear and shook her head causing part of her ear to separate from her head. 06. Huge Lie About the Assault on Susannah Felder.

AJ White was involved with the 'charity' in 2001 as a 'director' of the charity. During her tenure she noticed that public donations for the Children's Charity and the Peace Promise Initiative were being syphoned off by Patton West for her personal use. At the time AJ White wanted to ear mark the donations for use by the charity's that the mopney was raised for. Patton West resisted this as she need \$100,000 for legal fees for her son Chris Haywood who was in a custody battle for his daughter by his first wife Kendal Haywood. AJ White could not fathom what Patton West's son's legal issues had to do with the charity but as AJ White quickly found out the 'charity' was 'front' for fraud and money laundering. When questioning Patton West about the theft of the charities money Patton West advised AJ White that without her (Patton West) there would be no charity and that the money, all of it, belonged to her.

Anyway long story short an \$80,000 donation came in to the charity which was immediately removed by Patton West to fund her son's legal fees. This led to a confrontation between Susannah Felder, an 'employee' at the time and Patton West. Below in blue

In late July 2001, while I was on a business trip to Denver, Susanna Felder, a committed assistant for over 9 years and editor of Devra's writing, called me. She called me in severe distress as she had gotten into a heated discussion with Devra on whether or not I should be put on the BOD – there was no Foundation BOD at that time. Devra became so incensed that she attacked her and ripped clumps of hair out of Susanna's head. This was severe abuse and ultimately led to Susanna leaving DU within the month.

I returned to the office several days later and the first thing I did was to address this abuse in a staff meeting with Susanna in attendance. Jack West, who was present at the event, categorically denied it happened while Anandra accused Susanna of causing the problem. This collaborative deception was so shocking that I resigned, effective immediately. The cover-up was endemic and serious abuse issues were lied about and swept under the rug. The lack of integrity by Devra, her impropriety around money and her physical and verbal abuse of individuals were the reasons for my leaving.

Totally controlled by Patton West and regularly used by her as a false witness over the past 28 plus years.

We have a pattern of behaviour here from Patton West. Fund raising amongst the cult and the population at large. Any monies received for these headline 'good causes' is siphoned off by Patton West for her own personal use. Any criticism is met with lies, deceit and violence. The assault against Susannah Felder is almost a carbon copy of the assault against Beatrice McGuire. In that criticism or questioning of Patton West's actions is often met with violence. Patton West is not shy about making it clear to the members of her cult that their role is to fund her lifestyle - regardless of the fact that funds she steals from the charity, were notionally raised for specific projects, that were never meant see the light of day. Below here is a statement made by Patton West to the members of her cult telling them in no uncertain terms what their role was.

07. The Dangerous Working Environment & the Constructive Dismissal of Rebecca West (No relation to Patton West).

The following comments are from emails that Rebecca West sent fraud victim turned whistleblower John Watson in March of 2007.

"I have handed over many of the statements made by former employees of which are mostly already posted on your website to Dr. Cole in an effort to assist her. Dr. Cole was severely beaten on several occasions and proof is available."

"With all my heart, I hope and pray, the law firm that is currently reviewing her documents will help Dr. Cole recover her losses and/or dignity, as she has no money left after Devra extorted more than \$700,000 from her."

"Dr. Cole was forced to sign a "Quit Claim Deed" by Devra and will be yet another assault to her credit rating. My credit rating has taken a huge blow due to lack of timely paychecks, missing wages, bounced checks and caused me to be unable to refinance my home last month."

"Dr. Cole and I are very afraid, but this does not preclude me from standing up for what is right even if I lose my life over it!"

"To see the photographs of Pat Cole is so disheartening and frightening that my compassionate heart goes out to her, naturally responding to her pain, as I am no stranger to the many damaging affects of abuse, whether spiritual, psychological, or physical. In addition to my first hand experience, I observed Pat being treated in the most inhumane fashion, being humiliated and denigrated relentlessly for several months. This abuse had the affect of polarizing and terrifying Pat and the entire staff with dreadful displays of rudeness, humiliation, degradation, and sometimes even violent behavior, causing fear and paranoia among the ranks. I find this spiritual and emotional cruelty to be repulsive, creating a hostile and oppressive atmosphere in the work place."

CONSCIOUS FISCAL MASTERY

Wisdom and Integrity in Service

"Ultimately, I know intuitively that this work environment is offensive to me as a human being and noxious to my higher source sensibilities. I am sensitive to the fact that others must be having a similar experience, most notably Geoff. All of our debts and operational expenses as well as your personal living expenses have been paid by Geoff since September 06'(\$230,000). How can any of us be expected to function here in good conscience knowing the degree of his liability with regard to his money, his liability for back due payroll taxes, fines and interest on bounced checks, and considering he has not been paid to date (since September '06)."

"I received partial payment for my massive overtime hours but is far short of what she owes me and also does not include my credit rating damages, telephone charges, etc., etc.. My meeting yesterday with the Finance Controller [Geoffrey Reynolds CPA] was to discuss my unemployment issues as he had agreed to put me into a lay-off status, but has since reported to the State that I voluntarily quit! He recently treated a former employee as laid-off after Devra threw a book at her and then fired her. The companies owe large sums of money for WC, and ST, and Fed payroll taxes and was the reason he secretly laid-off Wendy Stuart, without confirming this choice with Devra first. He was attempting to protect his CPA license and as of last night pretends not to remember that we both saw her get hit by Devra with a large, heavy three-ring binder and fired on the spot! I also told him for the forth time yesterday evening, that in addition to her cruel verbal abuse, I had been slugged by Devra, three times in the back. I told him that I would be going to the State Unemployment Office with the truth and asked him, as my co-worker, if he would tell the truth regarding our working conditions. He said that it is his responsibility to represent his employer and he will not tell the truth unless specifically asked for the sake of keeping his job."

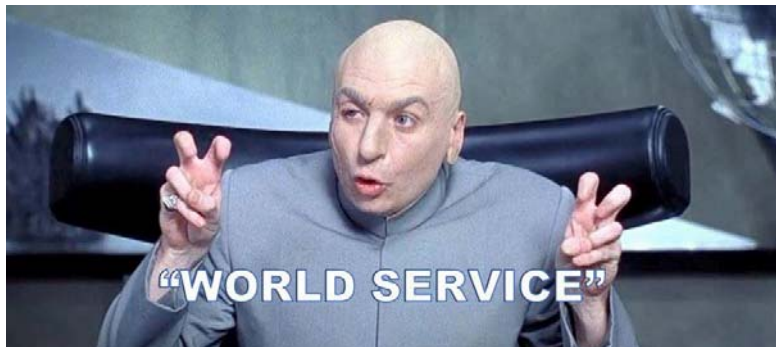

08. The Dangerous Working Environment & the Constructive Dismissal of Carlida Finch.

'Employee' Carlida Finch was both a witness to the brutality meted out by Patton West upon Dr. Pat Cole MD and was subject also to intimidation by Patton West who gave Carlida an ultimatum - she either agreed to join Patton West's cult or be fired. Below is an excerpt from a submission that Carlida made to the Montana employment tribunal. This excerpt deals with the violence meted out by Patton West upon Dr. Cole. Item 02 above entitled '**02. Huge Lie - The Extortion of Dr. Pat Cole's Entire Net Worth**' goes into more detail about this matter.

What working conditions were you not satisfied with? What steps did you take to remedy the situation prior to your separation?

Dr West was verbally abusive daily with Dr. Cole her "disciple" she attributed it to the "Law of Severity" required for spiritual enlightenment. Some time between Jan and Mar 2006 I overheard Devra tell Pat the she would "take a hammer and break every bone in her hands" Devra later told me that she did not care if she killed Pat because she, as an enlightened being had no ego so could spend her life in prison as easily as in a 6 million dollar home. On April 17th Dr. Cole came to work with bruises on her hands and wrists. I asked her about them and she said that she had whacked them. On April 22 I found a document written by Devra, it was an account of her asking the Masters about the "altercation" with Dr. Cole. According to Devra the Masters are the Shamballa Council, a group of enlightened beings that she meets with regularly in her meditations.



At this point, I did nothing. I had already been the subject of Dr. West's anger and had overheard her striking her "disciple" Dr. Patricia Cole, witnessed the continual denegration of Dr. Cole by Devra. Per Devra and Dr. Cole Devra was destroying Dr. Cole's ego in Dr. Cole's quest for "enlightenment" I have documentation re an assault made on Dr Cole by Devra, though I did not see the assault, I did see the bruises. I could not see any way to remedy this situation.

Our Comments. **Yellow Arrow:** The campaign of violence against Dr. Cole MD had nothing to do with Cole's enlightenment. But everything to do with extorting Cole's entire net worth estimated at \$1.3 million. **Red Arrow:** Only someone mentally ill would declare that an enlightened person would commit murder! Only a mentally ill person would suggest that they, as an enlightened person, would be just as comfortable in a 6' X 6' cell as in a \$6M mansion!

Nothing was achieved as Patton West just fielded multiple 'liars for hire' (loyal members of her cult) to dispute Carlida's evidence.

09. The Defrauding of Joseph Costantino out of \$10,000 in Wages and Overtime.

Joseph Costantino was employed as a 'manager' by Patton West but the only managing done within the cult was by Patton West! Joseph worked hard trying to please patton West which was nigh on impossible. By 2003 he had amassed \$20,000 in overtime and unpaid wages. As happened with countless other victims like Rebecca West, Kathleen Francisco, Diane Stoner etc. etc. the employees only hope of getting paid was to take Patton West to the Employment Tribunal. As happened with all the other employees that went that route Patton West just fielded multiple 'liars for hire' from her cult to dispute the evidence. Joseph ended up settling for 50 cents on the dollar and received \$10,000 after much expense and stress. 10. The Resignation of the BookKeeper.

According to Carlida Finch Betty resigned after a) being asked to do some 'creative' accounting by Patton West and b) after witnessing the violence being meted out by Patton West against her other employees.

What follows is an excerpt from the first email linked above from Carlida Finch.

She was hired as the controller early in 2006. She was put off by Devra screaming at me at our staff because I would not post job offerings that Devra had signed my name to, so that was one reason she left. Her resignation was April 5 and I left a few weeks later, April 28. I think Devra asked the 'controller' to do some "accounting" that she was uncomfortable with...perhaps the creation of invoices for what Pat "owed" her from the non-profit, the time line is correct for that assumption...I know that neither she nor the other employee at the time enjoyed Devra's constant haranguing of Pat...

As you can see from the previous several entries fraud and extortion is the norm for Patton West. In the above excerpt we have a witness to the extortion of money / property from Cole by Patyton West. Using the same fake invoice scam she used to steal the Victor MT property from the charity. Employees, Business Consultants anyone coming into her presence is a potential victim of financial / violent crimes. And this has been going on for 32 years right under the authorities noses. Patton West knows that the ability for authorities in western states to prosecute white collar crime is very limited. This is why she has only operated her cult / criminal racketeering business model in New Mexico, Montana and now Arizona. Had she operated in New York she would have been tried, found guilty and jailed decades ago. Martha Stewart was jailed for a lot less and for one incident this is a definite pattern of behaviour that has continued for three decades or more.



Can you see a Pattern of Behaviour here? More than enough to launch a R. I. C. O. investigation against Patton West and her Accomplices.

1. Business Consultant John Watson screwed out of Pay & Shares - Forced to go to court at great expense and over 5 years to get a win in court that Patton West ignores and along the way Patton West launched a campaign of violence against Watson and his wife and children and attempted to murder Watson. Why? For telling the truth! Ditto with Dr. Pat Cole MD. Patton West wants her entire net worth so launched a campaign of violence to intimidate her into handing over her fortune and her home to Patton West
2. Employees Susannah Felder, Rebecca West, Carlida Finch and Joesph Costantino all defrauded out of wages and overtime. Rebecca West, Joseph Costantino and Carlida Finch all went to the Employment Tribunal but faced a raft of liars from Patton West's cult who all disputed their testimony.

None of this criminal behaviour is by accident nor are they isolated incidents. This is all done on purpose by Patton West as the next entry '11' shows.

To be clear Patton West would offer job opportunities with apparently good wages and health benefits. The 'successful' applicants burnt their bridges by resigning from their current employment and, in some cases travelled thousands of miles to take up their employment, only to learn on day one that their nwages were to be cut by 20% and the health benefits they were promised were not given. This is fraud but out in the 'wild west' in Montana no one seems to care.

11. Huge Lies About Employment Opportunities.

Patton West is not interested in employees and certainly not interested in paying them a decent wage. One of the ways she increased the membership of her cult (low paid or no paid slaves) is to advertize non-existent jobs on the internet from her website. Job seekers from all over the USA would apply for these jobs and upon taking up employment on day one ther were informed that there had been a mistake about the level of wages which were reduced by 20% or so of the amount offered initially. Similarly the health benefits that were offered to prospects were also withdrawn on day one of their employment. This is all obviously illegal and a massive fraud but since Patton West only operated out of western states where the police and the

court systems are not set up for dealing with 'white collar' organized crime. For that reason she gets away with what amounts to 32 years of Racketeering and Domestic Terrorism in three western states. The subject of fake jobs offered on her website was dealt with in a recent bulletin entitled '[Students & Employees Two Routes to Ruin.](#)'

What happens to those who applied for jobs, agreed to travel to Montana only to find their salary has been cut and there are no health benefits? The following is an excerpt from a March 2007 harrowing email sent to John Watson by Patton West's office manager Rebecca West (no relation to Patton West).

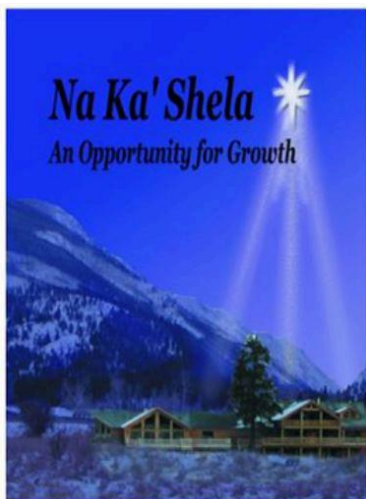
Dear John,

After more than 30 employees coming and going, (16 just since I started May 1, 2006, not counting myself, current employees or contract labor), there are currently three employees remaining. Two of the three are very much in her control due to fear and/or ignorance and have proven to me, I cannot trust them. I have been trying to get the monies she owes me before I end my contact with her, specifically a missing paycheck, overtime, overdraft charges and (wishful thinking) the bonus she promised me for the hundreds of hours of overtime I incurred. She sent her intimidating demand of me through her finance controller last evening, and I have until 5 p.m. today to talk to her. I must return and either give a 2-week notice and/or plan to be demoted from office manager to some other lowly position, (seems from historical accounting, I would become her personal care assistant).

As you can see from Rebecca's email many of the employees upon travelling to take up their positions find they have wasted a lot of time and money choosing to leave within days or weeks rather than be defrauded out of wages and benefits by Patton West. The ones who leave are the lucky ones. As the next incident shows.

12. The Sheriff's Sale - Hiding Four Million Dollars Worth of Assets from the Court.

In 2008 alone Patton West was found [guilty of assaulting](#) Dr. Pat Cole MD, was found [guilty of defrauding](#) John Watson and was the subject of a '[Sheriff's Sale](#)' to force her to pay past victims of crime \$2,000,000 in court fines and interest. Let us discuss what she did in respect of the Sheriff's Sale. Patton West, knowing she was going to be forced to sell her / the charity's assets at auction to pay \$2,000,000 in court fines and interest, she did two things to subvert the court (both totally illegal).

1. The first thing she did was to transfer ownership of the charity's property (Paid for with public donations) to herself. Then she put that property into a trust fund for herself and her eldest son Rob Meador. She justified doing this by asserting that she had loaned the charity several million dollars from her earnings as a public speaker. This is total bullshit as Patton West's speaking engagements if any existed were very limited. What in effect she did was defraud the charity out of every cent that came in from donations and then leave behind a series of fake invoices that made it look like she had loaned the charity millions of dollars.

What the members off her cult and the general public were unaware of was that the donations raised from both groups went into Patton West's pocket. They were used by Patton West to buy a property adjacent to the property owned by the charity. So to be clear there were constant 'fund raisers' to pay for the mortgage on the charity's Victor MT property however much of the money was used to buy her own property adjacent to the charity's property. Any excess was secreted away into jewels or precious metals or used to fund her luxurious lifestyle. As student [Elaine](#) confirmed in an email to the whistleblower. Unfortunately for Patton West a judge 'broke' the trust fund and mandated that the property be sold at auction and the proceeds given to her creditors AKA [Essex Ventures et al](#). We do not know how many cents on the dollar her creditors got but we suspect as the Victor Property was worth way less than the \$2,000,000 Patton West owed her creditors were left out of pocket.

2. The second thing Patton West did was to hide artwork and valuables worth \$4 million dollars in a 'lock up' / storage unit where they remained hidden until after the statute of limitations on theft expired. In 2014 artwork and valuables matching the missing assets owned by the charity (and funded by public donations) turned up in Arizona at her compound. If pathological liar and occult thief Devra Patton West no longer had those items, as she stated under oath in October 2009, then how does she account for items exactly matching those on the list showing up at auction in Cave Creek AZ and for sale from her website in 2014? 12. The Vicious Assaults on Lalita Jordan & Forcing a Demonic Entity into her.

After Lalita complied (she had no choice) Patton West emptied the trust fund into her own bank account with the result that Lalita's mother could no longer afford to pay the fees for her care home. 16. Several Suspected Murders including Lisa Swidler, Joseph Costantino. Two attempts to Murder John Watson

In 2002 Jack West, then husband to Patton West, warned John Watson that those who 'opposed' his wife had a habit of dying suddenly. Watson ended up being the subject of two failed murder attempts one in 2007 and another in 2023. We suspect that Lisa Swidler was murdered by Patton West as was Joseph Costantino. Both 'opposed' Patton West by telling the truth about Patton West's crimes and in Watson and Costantino's cases both took her to court / employment tribunal. Both these acts, and the one Lisa Swidler planned had she not been murdered, were or would have been very public and the TRUTH is very bad for Patton West's criminal business model.



Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). Within days of taking up employment the advertised wages are reduced and the advertised health insurance is withdrawn. By 2003 Joseph Costantino was owed \$20,000 in salary and overtime which Patton West refused to pay. After taking Patton West to an employment tribunal Joseph settled for \$10,000. In 2003 Joseph had facilitated multiple statements from employees about the crimes being committed by Patton West against them. Shortly afterwards Joseph died suddenly.

Shamballa being Flathead Lake which was one hundred miles north of her previous location. Dr. Pat Cole signed up to give her wealth away. Unfortunately for Cole she did not give up her wealth as fast enough so Patton West initiated a campaign of violent beatings to speed things up. Another employee, Carlida Finch, overheard Patton West saying that she did not care if she murdered Cole as being an enlightened being Patton West could as easily live in a 6' X 6' jail cell as in a \$6M mansion.

In 2005, having just sold her home, Marion Cantwell was kidnapped by Patton West, falsely imprisoned and beaten until she agreed to make a large donation to Patton West's good causes (herself). More recently, in November 2023, Patton West made another attempt to murder Watson using a different tactic. Reynolds did not announce this in advance! 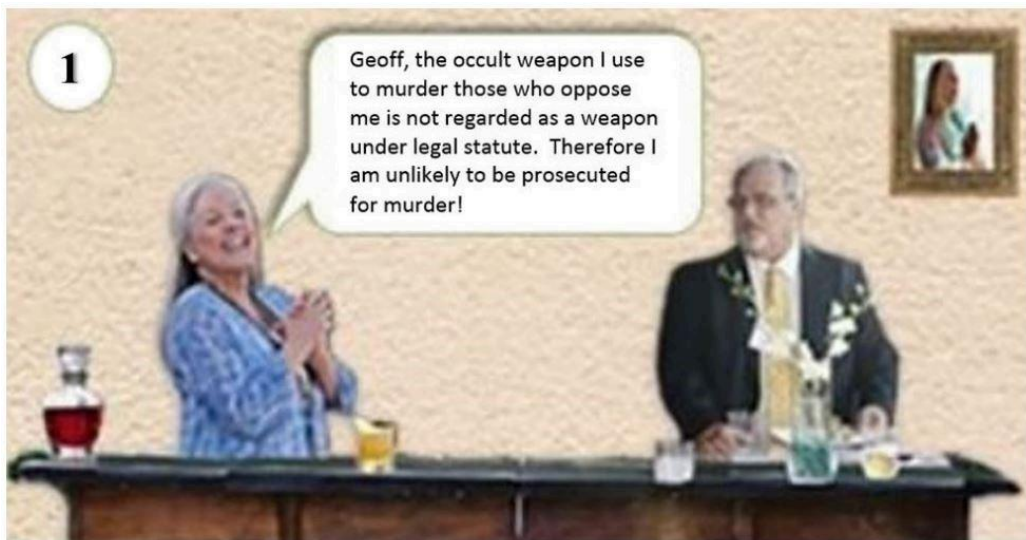


Between January 2002 & August 2002 the whistleblower worked as a business consultant for Patton West. Watson found rampant fraud. Patton West's husband Jack West told the whistleblower that those who opposed his wife had a habit of dying suddenly. A clear warning not to rock the boat.

17. The Two Attempts by Patton West to Murder John Watson.

One failed murder attempt in 2007 and the second attempt in 2023. Jack West may have warned John Watson in 2002 not to oppose his wife. The implication being that if he went public he might be murdered. However it was Geoffrey Reynolds CPA who in 2007 announced to the press that John Watson would be dead within 12 months or in jail for reacting to what Patton West was going to do to him, his wife and children.



The secret of Patton West's power and control over others is her use of the occult (Shamanism) as a weapon. Since Shamanism is not recognized as a weapon under legal statute Patton West has operated her cult / criminal racketeering gang for over three decades with apparent impunity. During that time there have been scores of victims of theft, fraud, extortion, embezzlement, violent assaults and an unknown number of murders. The dead cannot speak for themselves and to the authorities their deaths look as though they died of 'natural causes' when in reality they were murdered. Is it any wonder that Patton West, a criminally insane narcissist, presents herself to the world as a minor deity. Patton West attracts two kinds of followers the sheeple who become students of her unaccredited school for occult studies. This group obviously cannot see energy or read auras and therefore have no idea who and what they are dealing with i.e. demonic infested parasite. The second group are employees and consultants who quickly realize they are dealing with pure evil but choose stay involved anyway. They do so because they lack integrity, they lack a moral compass so they go along believing that in some way they can benefit from Patton West's criminality. Geoffrey Reynolds is a great example of the second group.



Reynolds joined Patton West's 'employ' in September 2006. After being duped by Patton West into loaning his life savings to her he fell totally under her control. Obviously he was very aware of what Patton West was capable of up to and including murder. The fact that he announced Watson's murder to a local news reporter on August 9 2007 speaks volumes. Another huge crime Reynolds committed was to make totally false statements to a Montana court that resulted in him getting a \$5,000,000 award from that court. The big lie was submitting a complaint to the court saying that he was defamed by Watson between 2002 & 2006. Since Reynolds only arrived in Montana in September 2006 how could he possibly have been defamed by Watson. He could not. Obviously Patton West put him up to it. Reynolds lacking any morality of integrity took a copy, and exact copy, of Patton West's complaint and simply put his name on it and presented it to the court as TRUTH. There is much, much more including the fraudulent application of a grant applicaton for \$30 Million to create a Spa Development and many more lies given to him by Patton West that he was happy to repeat. Lies he wrote to local newspapers denying that Patton West had assaulted Dr. Pat Cole. The assault actually happened in Sprinof 2006 and Reynolds joined the cult in September 2006. FINALLY WHAT ABOUT THE CULT / GANG MEMBERS WHO HAVE KEPT PATTON WEST IN BUSINESS FOR DECADES?

Williams and the other miscreants (Reynolds, Coffin and Jack West) did not mind ordinary folk being robbed, defrauded, having their life savings extorted or embezzled. Believing that her occult (hidden) weapon made it very unlikely she would ever be called to account for her crimes. The four miscreants below liked belonging to a cult / criminal gang and having a seat at the top table with the psychopath they worship. However while all four are obviously corrupt they are not stupid. After Patton West defrauded the US government out of \$500K they realised that unlike John Watson (who could not afford to fight the two lawsuits Williams funded for Patton West) the US government could and would spend millions to recover a few dollars.

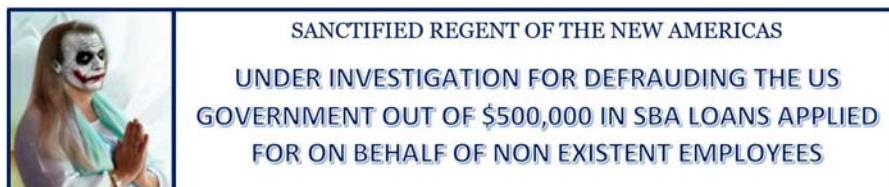

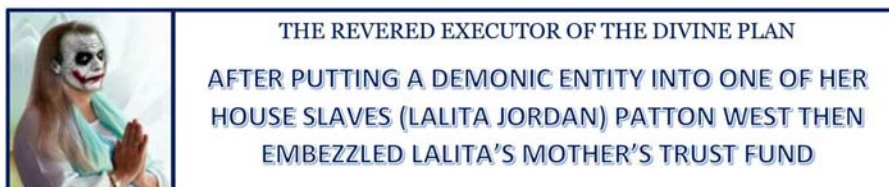
