After being chased out of New Mexico in 1995 in the middle of the night by one angry victim wielding a large gun, Devra West changed her name and her fake bio life story and created a new identity in Montana as the Ascended Master's Devra Ji (1995 to 2005) and Surya Ma (2005 to 2010). In 2010, it was clear after several visits to court as the defendant in fraud related lawsuits, after two arrest warrants, after a conviction for assault and after being forced to very publicly sell everything at a [Sheriff's Sale](#) to pay past victims of crime \$2,000,000 in court fines and interest, that it was time to move again. However, there was just one problem. Before Devra West could reincarnate herself as the Ascended Master Rishi Devra, later to become the [Sage of Sedona](#) and [The Regent of the Spiritual Hierarchy of the Western Hemisphere](#) she had to force every negative piece of news off the internet.

If the public has access to the truth about Devra West's sordid / criminal past on the internet it does not matter how much money she throws at creating multiple false identities. In the face of TRUTH & FACTS Devra West's lies and propaganda are seen for what they are.

One of the victims of West's criminality that would not give up and go away empty handed was management consultant, John Watson, who was defrauded out of wages and shares (like so many before and since) by Devra West after working for her as a consultant between January 2002 and August 2002. His subsequent actions resulted in her Victor MT charity to be [struck off](#) for fraud in January 2004, he also caused an [IRS investigation into her finances](#) in 2005 and successfully [sued her for defrauding](#) him in 2008.

Business partner of Victor Guru wins lawsuit

The former business partner of a self-styled spiritual guru in Victor was awarded nearly \$800,000 on Thursday in a civil case in Ravalli District Court.

Judge Jeff Langton awarded John Watson \$730,000 in compensatory damages and about \$46,000 in attorney fees and costs, but denied his request for \$300,000 in punitive damages.

Watson, a British native who now lives in Canada, sued Devra Patton West in 2003 for breach of contract, fraud and unjust enrichment.

However, his greatest threat to her criminal racketeering business model was his website which was dedicated to sharing everything he had learned about her crimes against him and scores of other victims. The information you are reading now is a small portion of that information. As shown above, once Reynolds' involvement in organized crime became apparent to his current employers, his resume or all reference to the eight years in Montana as part of West's cult, was removed. Then a few weeks later, his photos was removed completely. Then more recently, a photo of someone else was put up with Reynolds' name put underneath it. We impugn no wrongdoing on the part of the person 'masquerading' as Geoffrey Reynolds.

Gang members Reynolds, Williams and ex-husband Jack West, are 'wheeled' out as part of the propaganda campaign to persuade the public that con artist Devra West is a 'divine being' and wheeled out to publish statements of denial when West's crimes of violence, theft, fraud and extortion go public. As was the case with Devra West's vicious assault on Dr. Pat Cole MD in April 2006, covered by the Whitefish Pilot and Bigfork Eagle newspapers. Devra West was guilty as hell. Everyone in the cult knew it, as apart from many cult members being witnesses, Devra West issued a written statement to the cult mailing list admitting the assault. Within the statement, entitled ['The Law of Severity on the Path to Purification,'](#) West stated that the beating meted by her on Cole was delivered with grace, and that because the victim was a Nazi in the WWII death camps, the beating was appropriate and long overdue! Dr. Julio Williams' response was to [donate \\$100,000](#) to Devra West's 'world service' efforts and Geoffrey Reynolds' response was to frantically send emails to the service provider of the whistleblower's website in a vain attempt to force a copy of West's missive (admitting the assault) off of the whistleblower's website. You have to remember that Devra West, and all psychopath's stock in trade are lies. Indeed, Devra West makes no secret of this, telling the whistleblower in March 2003 that the truth does not matter if she can persuade the public that her lies are their truth! You can listen to an audio recording of Ms. West make these comments herself.

Of course, the truth was that Devra West had viciously assaulted Dr. Cole MD as part of a campaign of violence which included [murder threats](#) designed to separate Dr. Pat Cole MD from her \$1.3 million fortune which Devra West, with her accomplices help, succeeded in doing. In April 2008, Devra West was [convicted of assault](#) at a cost of \$500 fine and a six month suspended jail sentence. Who says crime does not pay? When the court verdict was announced in the [Whitefish Pilot](#) newspaper in April 2008, Devra West denied it all from her website insisting that this did not happen and that the court had thrown out Cole's claims which, according to West, were part of an attempt to extort money from her! Here is a copy of that posting.

Court Rules to Dismiss Bogus Assault Case:

All allegations have been expunged from court records. Irregularities perpetrated by Cole to court officials, more than indicated Cole's direct involvement in the conspiracy to entrap and discredit Dr. West. The allegations were dismissed as implausible.

TRUTH: Cole's misguided attempt to entrap Dr. West was a ploy motivated by Cole's need to cover-up her own in-depth financial fraud, as well as to hide her medical malpractice issues that had been divulged to Dr. West. Cole, a medical doctor, resented Dr. West's refusal to allow her to attend a healing training program, due to Cole's lack of morality and professional integrity.

And when John Watson, the whistleblower, won his fraud lawsuit against Devra West and news of that was published in the [Ravalli Republic](#) newspaper in October 2008; Devra West responded with another posting from her website.

Millennia Mind Dispute with John Watson:

Devra Surya Ma's legal team has filed for an appeal for the sanction ruling stemming from a technical error and timing matter. Additionally, contrary to Watson's claims of a "Big Win", lawsuits have been filed against John Watson for his many threats and criminal acts against Dr. West and her family members and will be diligently pursued by Dr. West's legal team.

TRUTH: No business contract between Dr. West and John Watson has ever existed. **The legal dispute was fabricated by Watson to leverage an extortion scam.** Any and all business proposals made by Watson were declined. Dr. West has no intentions of enabling an extortion scam, therefore no settlement of any kind will be entertained.

Having established that the truth really does not matter to Devra West and the senior members of her cult, let us now explore what part West, Reynolds and Julio Williams played in Devra West's denials, dirty tricks, intimidation attempts, murder attempt and subsequent criminal conspiracy to bankrupt him the motive is the same as the denials illustrated above:-

Devra West's claims to 'divinity' cannot prevail in the light of the truth. Therefore, any attempts by others to tell the truth or undermine her narrative are to be met with threats, intimidation and if necessary murder.

After the whistleblower John Watson announced his intention to sue Devra West for fraud, she mounted a campaign of covert and overt intimidation against him, which included the following actions by herself and those members of her cult that she mobilized against him as part of her vendetta.

1. The first thing she did was tell every employee at her compound to manufacture completely false statements about his conduct while acting as a consultant in 2002. These statements were intended to be used against him in court. One of those employees threatened with being fired if she did not manufacture a false statement was Anandra George; she subsequently [emailed a statement](#) to the whistleblower's lawyer retracting her false statement.

2. Dr. Julio Williams, and two other cult members at the time, obviously being directed by Devra West posted a [defamatory statement](#) about the whistleblower on West's website. The statement a pack of lies, endorsed by three people who he had never met, was intended to be read by the rest of the cult ahead of news of John Watson's lawsuit being published. According to [Barbara Costantino](#), Devra West's personal secretary for four years, she always lied about the reasons why people leave in an attempt to rewrite history and deflect blame away from herself. Another example of the truth not mattering if she can convince the cult that her lies are their truth! Just FYI, shortly after this statement was issued one of the signatories to it (and a recruit to West's latest fraud scam), Dr. Cornell, cut her ties with Devra West and as for the third, we all know what happened to Dr. Cole MD – her fortune was 'harvested' and she was expelled from the cult.

3. In January of 2007, only a month after Devra West commenced a campaign of occult 'under the radar' violent attacks against the whistleblower and his family, Julio Williams MD stepped up again for the leader of his cult / criminal gang and sent a lengthy threatening email to the whistleblower John Watson. Hear me very clearly now "THE LINE IN THE SAND HAS BEEN DROWN".

I have personally allocated Two million dollars for Dr. West defense and legal expenses. If you want to continue with your insanity go head but just know that you will have to go through me first. If you want to wrestle with me in the legal arena know that I will do everything in my power to bring you down.

Mr Watson, You will have your date in court. You fuck with me and you will meet your match.

One has to ask the obvious question which is why would someone a) send a threatening email on behalf of one of the party's in a legal dispute and b) why would they offer to put up \$2,000,000 towards that party's legal expenses? Obviously, this is no friendship or an employer / employee relationship. Julio Williams was / is a senior member of Devra West's cult / criminal gang and remains so to this day, as you will see if you keep reading.

Now, it is Geoffrey Reynolds' turn to take up the fight for the leader of his cult.

In March of 2007, after receiving several harrowing emails from an employee of Devra West's and with it obvious that others trapped inside the cult were being subject to theft, violence and intimidation the whistleblower made the decision to share what he had learned while researching his lawsuit against Devra West with a couple of local newspapers. This resulted in the [Whitefish Pilot](#), [Bigfork Eagle](#) and later the [Ravalli Republic](#) all printing stories about West's criminality which basically made it obvious that West's narrative of being a 'divine being' was a big fat lie. Reynolds, who only joined West's employee in September 2006, and coming from out of state did not know the whistleblower existed until he joined West's cult / criminal racketeering gang and was fully briefed by her. Even though Reynolds' employment was separated by John Watson's, that ended in August 2002, by over four years and even though he and John Watson had never met, Geoffrey Reynolds agreed to join Devra West's vendetta against him.

The reasons why he did this may have been motivated by the fact that shortly after joining Devra West's employ, he was manipulated into loaning his life savings of \$300,000 to Devra West. This is covered in more detail [here](#). Long story short, Geoffrey Reynolds agreed to be complicit in a plot to murder the whistleblower and when that failed agreed to be part of and to 'front' a criminal conspiracy to extort \$10,000,000 from the whistleblower. Both acts motivated by Devra West's need to force his websites off air so that she could reincarnate herself as the Ascended Master Rishi Devra in Arizona. Below are Geoffrey Reynolds' contribution to Devra West's criminal racketeering gang between 2007 and 2010 and more specifically the part he played in the vendetta / murder plot / conspiracy against the whistleblower John Watson.

1. While 'liar for hire' Geoffrey Reynolds CPA was being interviewed by the Bigfork Eagle on August 9 2007, he made a number of false statements about Devra West and her criminal racketeering business and her assault on Dr. Cole. Firstly, he misrepresented West's business as a normal corporation inferring that the directors of that corporation had discretion to make independent decisions, whereas in reality, the corporation was a front for a cult / criminal business that derived most of its income from organized crime. He also implied that others had been making trouble for Ms. West, when in reality, he knew full well that Devra West was the cause of most of the crime in the area and that while he was denying her wrong doing he was desperately trying to get her written admission that she had assaulted Dr. Cole off the whistleblower's website. Further, even though he had joined Devra West's employ some six months after the assault on Dr. Cole MD, Reynolds insisted that her injuries had been caused by an earlier fall at her apartment; this, even though the police were called to the assault by West on Cole and there were several other witnesses.

2. While talking to the reporter in what he thought was an 'off the record comment' Reynolds let it be known to Constance See (the reporter) that, and I quote, "Watson would be dead within 12 months or in jail for reacting to what Devra West was going to do to him and his family." Constance See took the threat seriously enough to share it with John Nielson, and IRS criminal investigator, who was auditing West's finances at the time. (Unfortunately for the IRS, and according to an ex-employee, Devra West shredded all of the incriminating documents before he could get to them.) John Neilson passed the details of the threat on to the whistleblower who shared his email with his then lawyer. Several days after Reynolds made his threat Devra West made a failed attempt to murder John Watson.



Above: The secret of Devra West’s power over victims and witnesses of the crimes she commits, and her hold over the members of her cult is her ability to use occult knowledge she acquired between 1990 & 1991 to intimidate and murder targets at a distance with plausible deniability. Hence Reynolds confidence that the whistleblower would either be murdered or be jailed for reacting to what West was going to do,

Additionally since December 2006, Devra Patton West has been targeting the whistleblower, his wife and his children with occult ‘under the radar’ violent attacks in a failed attempt to get the whistleblower to react in a way to these attacks that would send him to jail. These attacks continue to this day some 12 plus years after they started, and also just as predicted by Geoffrey Reynolds. The fact that Geoffrey Reynolds was so confident that Devra West would be able to successfully murder the whistleblower makes me believe that Devra West confided in him that she had murdered others, including the sudden and mysterious death of ex-student, Lisa Swidler, in 2005. In October 2009, Devra Patton West was deposed by the whistleblower’s lawyer in an attempt to find out what happened to the millions of dollars she had acquired through organized crime part of which was to be used to pay the award of \$760,000 that the court had awarded him. You can read Devra Patton West’s statement, given under oath, by [going here](#). Long story short, in a carbon copy of the playbook used against earlier victims of crime Devra West pleaded poverty and denied she had any assets stating that she was \$2,000,000 in debt and living in a caravan in Geoffrey Reynolds back garden!



Above left: In October 2009 Devra Patton West claimed to be \$2,000,000 in debt and living in a caravan in the back of Reynolds' garden in Montana. Center and right: Shortly after making that statement she moved into a \$7,000 a month rental in a gated community in Cave Creek AZ. Clearly the truth does not at all to Devra Patton West matter if she can convince the public and the courts that her lies are their truth!

In 2004, after Devra West's charity was struck off for fraud, she transferred the charity's main asset, a property worth \$1,250,000 in 2002 values, into a personal trust fund for herself and her eldest son, Rob Meador. At the same time, she stole \$4,000,000 worth of artwork and valuables, in 2002 values, and hid them in a lock up for ten years until the statute of limitations on theft had passed. The property and the artwork and valuables, worth several million dollars, were largely paid for by public donation and should have been sequestered by the Montana government and distributed amongst other Montana charities. However, by an elaborate fraud involving non-existent loans placed against the charity as debt, Devra West managed to steal the property for herself. However in 2008 a judge, in an attempt to force Devra West to pay past victims of crime the \$2,000,000 she owed them in court fines and interest, 'broke' open the trust and put the property up for auction to pay her debts. Having learned a lesson a year earlier in 2008, she pleaded poverty once again while being interviewed by the whistleblower's lawyer October 2009. West lied throughout the interview stating, amongst other things, that Geoffrey Reynolds was the financial master mind and that she was penniless and being supported by him. At one point in the interview, West was asked about the missing artwork and valuables and was shown [a list of those items](#) that the whistleblower and West's bookkeeper Cheryl O'Brien had drawn up in May of 2002. Upon being questioned about the items, Devra West declared that they were not her property and that the items were probably lost, stolen or carried off by others after she left the property. 4 Q. If you would take a look at that, Ms. West.

7 Q. Can you tell me what it is?
8 A. This was created by some of the non-profit
9 people. It was shown to me. They were trying to I
10 believe at the time convince me to become involved in
11 trying to -- they were trying to not lose the
12 property down there. It was I think -- I'm thinking
13 they were late on their payments or whatever. So
14 this was created by a couple of people.
15 Most of it is pretty far-fetched. I mean I
16 can tell by looking at it that the monies -- and I
17 told them that I thought this was ridiculous. I
18 thought that, you know, it was pretty crazy. I
19 I really walked away from my life. I walked away
20 from all of my possessions. All of this stuff was
21 left at Naka Shela for over a year and a half. The
22 property has been entirely furnished with my personal
23 family's furniture and so on. And by the time they
24 got around to actually transporting my items back to
25 me, well over half of it had been carted off. Entire

1 rooms full of furniture were missing, had been carted
2 off, as well as a great deal of this.
3 Anything that was really of value has been
4 sold. I mean, I know that I sold a few things way

Devra West clearly telling lies states on page 61, line 20 that she walked away from all of her possessions. On page 61 line 25 and page 62, line 3 she states that anything of value had been carted away and or been sold. On page 62, line 23 she states that she thought Esther Michaels had drawn up the list knowing full well it had been created by the whistleblower John Watson and her ex-bookkeeper Cheryl O'Brien back in 2002. In 2014, exactly ten years after all the items on the list of assets disappeared they all reappeared as if by magic either for sale at auction (see below), as for sale on West's website and more recently as part of Rishi's art collection which can be viewed by going [here](#).



Above top row far left: A small fraction of the items stolen from the Montana charity that Devra West said under oath did not exist. Second left: Reynolds overseeing the auction of stolen property. Third left: West standing next to a brass Buddha that must be worth tens of thousands of dollars. Far right: part of the expensive illusion created like a Hollywood production with hundreds of thousands of dollars acquired through organized crime.

Above lower row: In her statement given to the whistleblower's lawyer in 2009 West said that she had given up all her possessions and that the items she is standing by / walking by above were lost or stolen. Yes they were stolen by her and held in a lock up until the statute of limitations had passed and now paraded for all to see as if to indicate that whether intimidating victims, murdering victims or committing grand theft she is above the law.

4. After the murder plot failed, and with the whole of Montana knowing that Devra Patton West was a vicious criminal, her multi-million dollar a year business model was dead in the water until they could force his websites down.
