Dear Esther,

We are all very much looking forward to seeing you on Monday. Many great things are on the horizon, and the whole staff is eager to engage in a creative and productive time period with you.

It is our continuing quest and collective responsibility to start and sustain all new endeavors from a positive spin state, so that the exponential factor of abundance can be ignited for all concerned. In this light, there are a few elements of your communication dated August 4<sup>th</sup> that call for consideration in order for the overall agreement between yourself, Devra, and the organization to come into a positive spin state.

Most of the points you included are agreeable, and there are a few that require further clarity: 1) the additional monthly fee 2) the number of return trips to Atlanta during the 6-8 week period 3) the percentage on grant monies and urban conference event sponsors. (I noticed you conference sponsors at 20% in your email, when the original contract states 10%. Perhaps this is just a typo?) You and Devra will have an opportunity to review these points during your visit, with the intention to achieve clear balance and the ring of truth at all levels.

As the basis of your discussion with Devra, I'd like to reiterate the original verbal agreement as we understand it: \$2,500/month, travel expenses to and from Montana with one roundtrip return during the 6-8 weeks, lodging at the Questhouse unless otherwise arranged, and a vehicle during your time here. Food was not discussed, however you may be invited for occasional meals at Devra's home. Otherwise meals will be up to you.

To make the best use of our collective efforts, it would be helpful if you could outline how you see the first few days unfolding and what you anticipate needing from Devra and the staff. You can email me anytime over the weekend with this information. Again, we're looking forward to supporting your expertise!

It'll be great to see you again and be able to spend more time with you. I hope to show you a bit of our beautiful state while you're here! There are some beautiful hot springs, hikes to alpine lakes, and late summer/fall is a magnificent time to be here. We'll be sure to take time to recreate and deepen our connection.

Dear Esther,

We're looking forward to seeing you on Monday, and are eager to work with you to serve Devra's projects. I sense that many good things will come out of the upcoming time period.

It is our intention and collective responsibility to achieve the "exponential factor" from the beginning of your time here, and to do so we must ensure that each element of exchange is in a positive spin state. This, in turn, ignites tantra between all individuals concerned and opens the gateway of financial flow that is our envisioned potential. Devra has reviewed your communication dated August 4<sup>th</sup>, and although the general premise of the arrangement is good and consideration for your needs is open for discussion, there are elements that contribute to an overall negative spin state in the communication. She requests that you review the energetics and identify what changes are necessary in order to bring it into the 66.6% of positive spin state. She will be happy to review this with you when you arrive on Monday.

Without taking the time to go into detail here, the points requiring further clarification from higher guidance are: 1) the additional monthly fee 2) the number of return tickets to Atlanta during the 6-8 week period 3) the percentage on grant monies and urban conference event sponsors. (I noticed you had it at 20% in your email, when the original agreement was 10%. Perhaps this is just a typo?) The other points in your email were agreeable.

We'll presume that you will join us in Montana as planned under the original verbal agreement between yourself, Justin, and Devra, until you and Devra can further discuss and seek guidance on your proposed changes when you're here. The original verbal agreement as we understand it was: \$2,500/month, travel expenses to and from Montana with one roundtrip return during the 6-8 weeks, and a vehicle during your time here. Food was not discussed: you may be invited for occasional meals at Devra's home, but otherwise meals will be up to you.

If we haven't already spoken by the time you receive this, I am arranging for a taxi to meet you at the airport and transfer you to the Questhouse on Sunday evening. They will have a sign with your name on it. If there are any problems or flight delays you can call Larry or Elaine at 880-4050, or you can also call my cell number. On Monday, the office staff starts arriving at around 8 AM, and you're welcome to set yourself up in my office (Cindy has moved to the far office). Your first meeting with Devra will be at 11:30 (time tentative).

Outline your specific areas of focus for the first few days, what you expect you'll need from Devra and the staff members.
