So here are six short excerpts from the day to day diary of John Watson. Watson being one of countless victims defrauded, robbed, mentally and physically abused, threatened with murder and subject to two failed attempts to murder him. Watson a fraud victim that, unlike 95% of victims decided to do something about Patton West's reign of terror. In 2006 Watson put up a website to tell the truth of what was happening and to warn the public to stay away. He did so after he and his wife and children were targeted by Patton West. There will doubtless be many more pages added to the diary in the days ahead. But now let us give some context to our claims which we have no doubt will be verified by countless other victims when we all get into a criminal court preferably held under R. I. C. O. statutes. Let us now demonstrate 'MOTIVE & OPPORTUNITY. Not necessarily in that order....

### First data Point.. OPPORTUNITY...

Between 1990 & 1991 Patton West attended the 'Robert Jaffe School for Energy Mastery.' **So Devra Patton West, "Was willing to do whatever to achieve her ends," and, "A brilliant, powerful, manipulative, delusional psycho/sociopath." Fed up with picking victims off one at a time Patton West needed to solve the age old problem of how to commit crime on an industrial basis and avoid being prosecuted.**

Patton West, a prolific abuser of banned drugs was already embedded in the 'new age' community so it was a short jump from there for the egomaniac / narcissist / psychopath to want to become a guru. After all, gurus control the lives of their followers and Patton West was into controlling others' lives big time. Here is a statement from one ex-cult member...

*In the group we were urged to adopt Islam as our religion. I took that seriously and set about learning the five times-a-day prayers, etc. I became extremely straight-laced and wore a scarf on my head as much as possible, since I was told I needed to protect against astral beings. On top of following Islamic practices, we were given a number of Sufi practices, such as chanting in Arabic thousands of times each morning and evening. It was quite time-consuming. And we were often asked to participate in costly events and give sizable donations to the group. [Ex-members of Devra West's cult will know this happened regularly to them.] We were told that all sorts of things were "against God".*

*Things like Reiki healing, which I had been involved in for some years. Over time I would learn that homosexuality and eastern religions were also "against God". By then, I had become quite disgusted with all that was being asked of me and I wrote an email to Dr. Jaffe announcing that I was leaving the path. Jaffe responded months later and threatened that I could become sick and die from something like cancer for leaving. That did not happen. Instead, I discovered some years later that Jaffe's own wife got ill with cancer and died from it. [Ex-members of West's cult who went public will know about sudden deaths and threats of murder.]*



Above: The occult (hidden) knowledge that Patton West acquired at the Robert Jaffe School for Energy Mastery gave psychopath Patton West two things:-

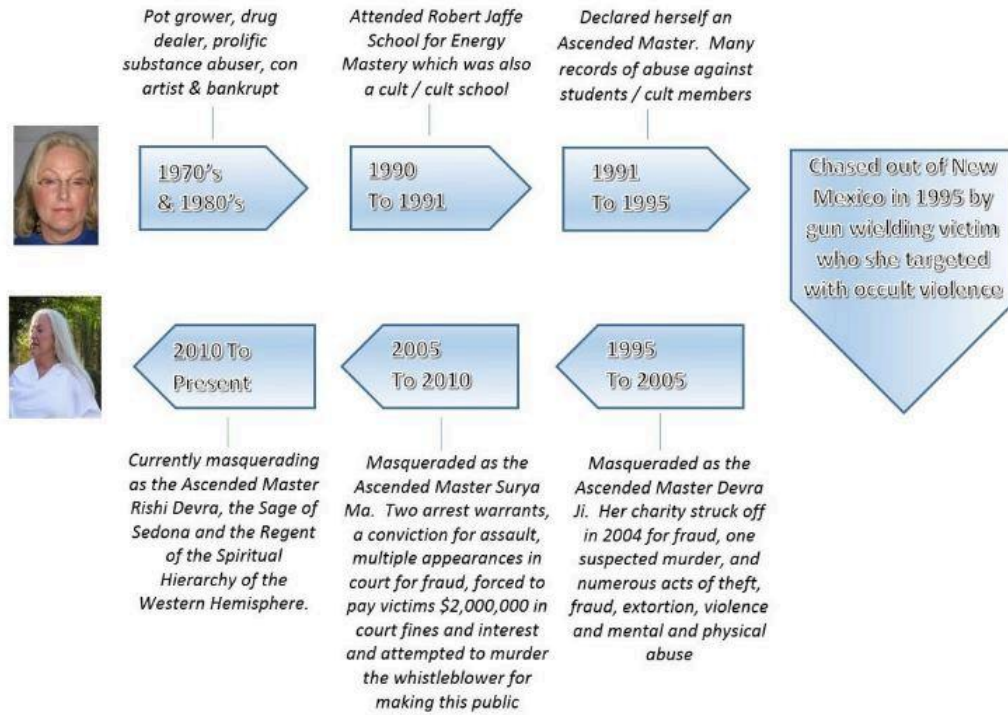
1. A weapon not recognized as a weapon under legal statute. A license to kill with impunity.

**After completing the course, Patton West declared herself to be an Ascended Master and that anyone not agreeing was 'blocking the energies.'**

It is obvious from her actions (Ye shall know them by their fruits) that Devra West, with the full cooperation of her husband Jack West, used the occult (hidden) knowledge she had acquired, not for the good of humanity, but to leverage her life long criminal tendencies. And is it surprising this is where Patton West came from. Her pedigree. Her real life bio / life story...



Whether criminality or insanity came first is up for debate, however, it is said that a leopard cannot change its spots. It is clear that Devra West could not change hers either, as is borne out by the information we have compiled on two websites and that others have compiled on other websites.

Even though in reality they are perfectly healthy. Others may not take her seriously. Those that do not take her seriously are subject to a campaign of occult attacks which convince the 'target' that there may be something wrong after all. Until the 'target' pays their health gets progressively worse. Not because they are really ill but because Patton West ramps up the level of attacks and adds other negative conditions to the mix. This may include vomiting, diarrhea, migraine, headaches and sleep deprivation. At some point the target becomes a 'believer' and pays up.

*Above: Probably nothing to worry about that Dr. Julio E Williams MD, himself a pathological liar, is hosting a 'Sacred Sunday with Rishi' AKA Patton West. Though Williams has been a student and disciple of this con artist for 20 years surely he would not provide a venue for her and endorse her ability to deliver miracle cures for a large fee? Would he?*

We estimate that scores, maybe hundreds of victims, mainly employees, students and business consultants were subject to acts of **TERRORISM** by Patton West as she sought to rob them, defraud them, extort money from them and if they went public to intimidate them into remaining silent. Those that seriously opposed Patton West were slated for murder. Here are some examples:-

1. Office Manager Rebecca West (no relation to Patton West) The following excerpt from a harrowing email entitled '[Help Me!](#)'

"I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. [I need support in how to deal with her shamanic witchcraft.](#) Can you tell me more?"

SHAMANIC WITCHCRAFT = **TERRORISM** = **COERCION** (In this case to intimidate Rebecca into remaining silent about the crimes going on around her at work.)

**2. Jamie Haywood getting divorced from Patton West's son Chris Haywood. Both Jamie and her infant child the subject of occult attacks. As Jamie's [email](#) makes clear the motive is to intimidate Jamie into giving up her infant daughter to the family from hell.**

"I thought that i was going crazy and thought there was something wrong with my daughter. Until my mother took me to a true gider and this wonderful woman [told me that i had a spell put apun me.](#) She then started to test where it was, lo and behold [in the left front side of my brain.](#) Ya [something to make me go crazy and what ever els.](#) And now thats not all of it [she also put one in my 11 month old daughters orgains.](#)"

SHAMANIC WITCHCRAFT = **TERRORISM** = **COERCION** (In this case an attempt to intimidate Jamie into giving up her infant child which did not succeed). A Failed attempt to subvert the court case.

**3. Kendal Haywood a pevious wife of Chris Haywood's that was divorced several years before Chris Haywood divorced Jamie Haywood.**

Same playbook as used later against Jamie Haywood. Weeks and months before the child custody case was heard in court Patton West relentlessly targeted Kendal to the point where she thought she was having a nervous breakdown. While Patton West's lawyer deposed John watson in 2010 the subject of Kendal Haywood came up. Patton West's lawyer Mr. Bartlett remarked that it had been discovered that kendal haywood had mental health issues. Yes of course she did. Most people would not have mental problems if they were being targetd 24/7 for weeks and months on end by Patton West. Review the grid above to see what John watson had to put up with during the 6 days mentioned in the grid. Patton West has been targeting him and his family for 18 plus years!

**4. Michelle Fetveit, a neighbour of Patton West's came under occult attack and was woken up at 3.00 am like all the other victims. You can listen to her audio statement by going [here.](#)**

The attacks came about because patton West was stealing the water rights from Ms. Fetveit. When Ms. Fetveit pointed out that patton West had no rights to the water she was stealing the occult attacks started.

**5. Victims who did Nothing because of Fear.** There are many more examples of Patton West using **TERRORISM** against employees and students. Just as interesting are the cases where members of Patton West's cult were robbed, defrauded or had money extorted from them and they responded by doing NOTHING. For example Mike Hendrickson defrauded out of \$200K. He was mentioned in the [Whitefish Pilot](#) newspaper article. [Dave Kushner](#) defrauded out of \$30K. [Marion Cantwell](#) was kidnapped, held captive and beaten until she agreed to give up a large portion of the sale price of her home. She was told she would be murdered if she went to the police. She did NOTHING.

**6. There are many victims of fraud at the hands of Patton West. We mention some of them below here. Investigators need to interview each of these victims to ascertain how many of them were treated to TERRORISM at the hands of Patton West.**

**7. Then there are the dead who cannot speak for themselves.** According to Patton West's ex-husband Jack West there were at least two murders prior to 2002. Then there was lisa Swidler in 2005. Lisa witnessed the crimes committed against Mike Hendrickson, Dave kushner and Marion Cantwell. Lisa tried to leave the cult and died before she could report the crimes to the police. Joseph Costantino, an employee of Patton West's, was owed \$20,000 in wages and overtime. As with Hendrickson, Kushner and Cantwell Patton West refused to pay him. Joseph took Patton West to the Employment Tribunal and was awarded \$10,000. Joseph died shortly afterwards.

Patton West tried to murder him in 2007 and again in 2023. Patton West's 'policy' is to offer employees high wages and conditions as an inducement to get them to give up their employment elsewhere and in some cases move from different parts of the country to work for her charity (cult). 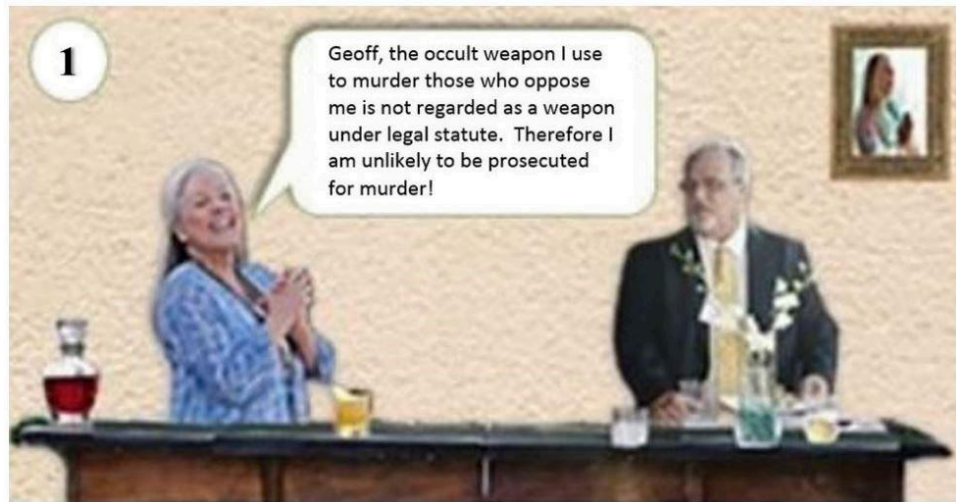
