


Domestic Terrorism for the FBI's purposes is referenced in U.S. Code at 18 U.S.C. 2331(5), and is defined as activities:

- Involving acts dangerous to human life that are a violation of the criminal laws of the United States or of any State;
- Appearing to be intended to:
  - Intimidate or coerce a civilian population;
  - Influence the policy of government by intimidation or coercion; or
  - Affect the conduct of a government by mass destruction, assassination or kidnapping; and
- Occurring primarily within the territorial jurisdiction of the United States.

We are talking about 'Shamanic' visioning used as a TERRORIST weapon by Patton West to facilitate theft, fraud, extortion and embezzlement. We know Patton West attended the 'Robert Jaffe School for Energy Mastery' for 18 months between 1990 & 1991. Which is where Patton West acquired occult (hidden) knowledge which, Patton West, not being spiritual evolved went on to use the knowledge as a weapon primarily to feather her own financial nest at the expense of everyone over the past three decades. 




So to make this very clear let me explain this 'Barney' style.

So it is not a problem for occult 'masters' (psychopathic killers) like Patton West to 'hack' their victims energy / astral bodies and, using Shamanic Visioning in Patton West's case, induce illness, suffering, pain, serious illness and death. Which is exactly what Patton West ahs been doing for 33 years since she aquired this knowledge while attending the Robert Jaffe School for Energy Mastery between 1990 & 1991.

What follows are just a few short excerpts from Watson's diary of **TERRORIST** attacks. Remember this has been going on for over 18 years...

**19 March 2025.** Since last July my groin area has been attacked pretty much every day. To be clear if I sit on a chair my prostate / groin / testicles are targeted. It results in me getting so sore it is hard to sit down. I am attacked in the same way while in bed which makes sleep difficult. I am even attacked in the same way while lying in the bath. I would say that 97% of the attacks to my groin are designed to cause pain. Though I classify those attacks as rape because it feels like I have something placed / lodged inside my rectum. The other 3% are out right rapes that end in an orgasm.

**April 30 2025.** The attacks to my groin were followed by three hours of shamanic rape designed to cause pain and humiliation. This on top of migraine headaches, nausea etc. The sound of whirring insects / wind noise in my right ear accompanied by loud hissing in my left ear.

**May 02 2025.** The worst night so far. The shamanic rape started before I went to bed at 6.30 pm (we go to bed early hoping we will get some sleep). The rape started while I was sat in my arm chair. I went to bed at 6.00 pm and the rape continued until 2.00 am. This version of 'rape' designed to cause pain. I was very sore when I got up the following morning. The rape accompanied by loud buzzing insect sounds in my right ear. So whirring noise in my right ear with loud hissing in my left ear.


**July 5 2025.** I got up at 5.00 am having woken up at around 3.00 am with the 'pounding' frequency in my ears which is designed to do just that. Designed to wake me up and keep me awake. I watched TV until about 6.30 am. However while sat in my lounge watching TV rape attack started again at around 5.30 am. Patton West uses this form of attack most because it demonstrates to her victims that she can reach them at any time. Also to the mind of a criminally insane psychopath like Patton West, humiliating her victims, by forcing them into having sex against their will is a real bonus!

The three excerpts from Watson's 'attack diary' along with scores of others have up until recently taken the form of attacks against the physical body. In other words the attacks are designed to make the target physically ill or injure them or murder them. However after getting nowhere with attempts to intimidate Watson with physical violence or murder Patton West has changed her tactics over the past few months.

Having failed at using occult (hidden) physical violence to intimidate Watson Patton West now intends to cause him as much mental anguish as possible. In short Patton West's end game / objective is to create the impression that Watson is suffering from **mental problems**. This tactic has been used against her own family members in the past with mixed success. So in addition to the ongoing physical attacks (that Patton West has been using against Watson non stop for 18 plus years) Devil West is now terrorizing Watson by using 'voice to head' deliveries.



Above: Focussing on the head. The above are examples of what the CIA and other intelligence agencies can do. Patton West uses 'Shamanic Visioning' to achieve the same outcome. This is all explained in quantum physics and specifically involves the use of quantum entanglement.

Here are three examples of what Patton West is currently delivering to Watson via 'voice to head' (i.e. shamanic visioning terrorist attacks).

1. TUNE Projected into John Watson's HEAD.
2. CONSTANT NOISE Projected into John Watson's HEAD.
3. WIND NOISE Projected into John Watson's HEAD.

Item (1) is projected into Watson's head 24/7. Item (2) tends to accompany a vicious attack to his physical body as in Shamanic Rape, attack to his head, genitals, kidneys, prostate etc. This sound gets louder as the evening comes on and is used with the intention of keeping Watson awake all night. However the Rife frequencies help to dial that back. Item (3) is mainly used in conjunction with an attack against his physical body and like item (2) is loudest at night. None of the examples we have given here are exactly like the real thing but are the best examples of the sounds that we could obtain from the internet. Item (2) is more like a distant diesel engine or like washing machine on its final rinse cycle.

### THIS TAKES PATTON WEST'S USE OF TERRORISM TO A WHOLE NEW LEVEL!

Let us now give you two or three examples of how Patton West has used this form of TERRORISM against members of her own family:-

1. **Kendall Haywood (Chris Haywood's ex-wife and Patton West's ex-daughter in law).** We have a previous bulletin that spells out what happened to Kendal at the hands of Patton West in detail. **The Problem.** Kendal is divorcing Patton West's son Chris Haywood. Chris Haywood has a [criminal record](#) for forgery, drug abuse and traffic violations (the apple does not fall far from the tree). How does the father obtain custody of an infant female child if the father is a porn loving, wife beating son of a criminally insane psychopath? Simple you make the mother look a lot worse than the father in the eyes of the court. In plain speaking Patton West had to literally SUBVERT the court process in favour of her son!



Above: How does a wife-beating, porn-loving husband gain custody of an infant female child from an all American Apple Pie sweet wife? Simple, if you mother is an occult master. Target the son's wife day and night with occult attacks until she thinks she is going crazy. Then the mother brings in a female doctor, a member of her cult, to diagnose her as such.

**The solution.** In brief Patton West, in the run up to the court child custody hearing, relentlessly targeted Kendal day and night with the very same occult attacks being directed at John Watson and others 24/7 and 365 days a year. In addition to the physical attacks directed at her Kendall she was also subjected to the 'voice to head' treatment that Watson is now enduring. We know this because Watson corresponded with her in an attempt to help her. Unlike Watson who knew what was happening Kendal had no idea why she was hearing sounds, voices, music etc. in her head so sought medical advice. Long story short in addition to targeting Kendal relentlessly with TERRORIST attacks Patton West also arranged for a doctor in her cult, Dr. Pat Cole MD, to give a 'professional' medical opinion that indicated to the court that Kendal was having mental problems. This was of course a pack of lies and Cole knew it being a business 'partner' to Patton West. Cole was also a long term student at Patton West's non-accredited school for occult studies and was therefore totally under Patton West's control. Long story short the court process, having been totally subverted by Patton West, gave custody of Kendal's infant daughter to Patton West's son. And Corinne Coffin, another long term cult member paid \$80,000 to fund Patton West's son's legal costs.

Fast forward to 2010 when the whistleblower John Watson was being 'deposed' by Patton West's lawyer. During the proceedings Watson brought up Kendal Haywood to which Patton West's lawyer answered with, Have you not heard she was diagnosed with **mental problems!**

Proof that karma can be a bitch occurred when a few short years later Patton West used the same tactics against Dr. Pat Cole MD. Long story short Cole was viciously beaten by Patton West while having her entire net worth extorted from her by Patton West. The [Whitefish Pilot](#) newspaper gives details. **2. Jamie Haywood (Chris Haywood's second ex-wife and another of Patton West's ex-daughters in law).** As with Kendal Haywood above Patton West used the exact same tactics against Jamie Haywood (the tactics currently being used against John Watson and countless other victims).

**The Problem.** As with Chris Haywood's first wife Kendal the problem is how do you get a court to hand over a female infant child to a porn loving, wife beating drug addict?

**The solution.** You make the mother look worse than the father. So as with Kendal Haywood Patton West targeted Jamie Haywood day and night up until the child custody hearing in the hope of subverting that court case just as she did successfully with Kendal Haywood. There is little point in going into detail suffice to say that Jamie Haywood wrote to the whistleblower John Watson asking for help. Here is an excerpt from [the email](#) Jamie Haywood sent Watson the day before the child custody hearing took place. Jamie is semi illiterate but the true meaning of her comments is easy to understand...

I finally found this websight and have been searching for you and Pat Cole due to the fact that my daughter and i have been subjected to this nasty woman. I thought that i was going crazy and thought there was something wrong with my daughter. Until my mother took me to a true gider and this wonderful woman told me that i had a spell put apun me. She then started to test where it was, lo and behold in the left front side of my brain. Ya something to make me go crazy and what ever els. And now thats not all of it she also put one in my 11 month old daughters orgains. So my lady took some time and finially removed this wicked spell off of me and my daughter. then she told me that i would be protected.

She was being targeted by Patton West both to cause physical harm and doubtless targeting Jamie's sense of psychological well-being targeting her with 'voice to head' message, music and sounds just as with Kendal and just as with John Watson and countless other victims. Jamie also mentioned this in her testimony while giving evidence to the court. This from pages 119 & 120 of the court transcript.

On this occasion the TERRORIST attacks failed and Jamie got to keep her daughter. But the above another example of how Patton West subverts court cases. More on that later. But now just a few more examples of Patton West's use of occult (hidden) under the radar TERRORIST attacks against victims of theft, fraud, extortion and mental and physical abuse.

**3. Rebecca West** (no relation to Devil West). In March of 2007 John Watson started to receive a series of emails from Rebecca West then an employee of Patton West's 'front' company for organized crime. The emails were harrowing and described the absolute nightmare of working for Patton West. One paragraph within an email entitled ['Help Me'](#) again makes it very clear that Patton West is using her occult weapon against anyone who her psychosis takes a dislike to.

**I will not return and subject myself to her violent and abusive behavior! I continue to awaken from a sound sleep (on many occasions) at 3:00 a.m. and last night being one of those nights in which I have the feeling of impending doom, and is the reason I finally really took a look at your website and contacted you. I need support in how to deal with her shamanic witchcraft. Can you tell me more?**

Looks like Patton West was giving this person **'mental problems.'** Is there any doubt in any ones mind that Rebecca West too was the subject of TERRORIST attacks at the hands of Patton West?

**4. Beatrice McGuire.** While attending a seminar in Montreal in 2002 Beatrice McGuire 'called out' some obvious lies by Patton West. Beatrice was instantly rewarded with a vicious attack by Patton West that ripped part of Beatrice's ear from the side of her head. This attack was witnessed by everyone attending the seminar and another attendee gave a [statement](#) about what she witnessed. After getting a lawyer's letter from Beatrice, Patton West agreed to pay for Beatrice's medical expenses. In the letter to Beatrice Patton West does not accept any responsibility and does not have the same recollections of that event as Beatrice. And a score or so of other witnesses. She says she is paying as a humanitarian gesture or words to that effect. In March 2003 Patton West insisted on a private meeting with John Watson who had announced he was going to sue Patton West for fraud. **5. Michelle Fetviet.** Ms Fetveit was a neighbour of Patton West's. Long story short they got into a dispute over water. Basically Patton West was stealing their private water supply. 
**Spiritual guru pleads guilty in assault**

A Lakeside woman who claims to espouse timeless spiritual truths pleaded no contest to one count of misdemeanor assault late Monday in an 11th-hour plea bargain.  
Her trial had been scheduled to begin Tuesday at 9 a.m. in Flathead County Justice Court.  
After entering her plea, Devra West was sentenced to a six-month deferred jail term and fined \$500.  
Dr. Patricia Cole of Whitefish alleged West in 2006 hit her with a shoe and shoved her.  
Justice of the Peace David Orsley issued a restraining order against West, a self-styled religious master who calls herself Surya Ma, in October 2006.  
West's trial was postponed from March 11 after she failed to show up for a March 7 pre-trial conference in Flathead County Justice Court. She reportedly was in the Yucatan participating in a documentary on Mayan prophecies.  
West's trial originally was scheduled for April 2007. Prosecutors said they offered West the same plea deal she accepted Monday about a year and a half ago.

**CONVICTION FOR FOR ASSAULT**

Watson an ex-marine was not impressed by Williams' attempt at intimidating him. Watson being the plaintiff in a lawsuit brought against his cult / gang leader. When Williams' threat was ignored Patton West upped the anti by getting another brainwashed and conditioned droid in her cult to announce Watson's impending murder. Accordingly on August 9 2007, some 6 months after Williams' expletive laden threatening email to Watson, Senior cult / gang member Geoffrey Reynolds CPA, announced Watson's impending murder by Patton West to a local newspaper.

predicted. And just FYI the campaign of occult attacks that Reynolds announced against Watson and his wife and children continues to this day some 18 years later!




